HCAFA HAS BEEN BUSY:

1. Informing Members about Why Joining HCAFA Matters.

We consider informing adjuncts about what HCAFA, IEA (Illinois Education Association), and NEA (National Education Association) do for adjuncts our number one job. We encourage all adjuncts to attend the meetings, programs, workshops and representative assemblies that HCAFA, IEA, and NEA offer. Members who join HCAFA automatically become members of both of our parent organizations. To enroll as a member of HCAFA, contact Gary Wilson at hcafamembership@gmail.com with your name, phone, home address, Harper division/department, and non-Harper email address. Gary will send you an application through campus mail.

2. Encouraging Fair Share Fee Payers to Become Full Members.

Most adjuncts have chosen to become full members of HCAFA; some have chosen to pay "fair share" fees instead. Fair Share fees are only \$15 less than full membership dues per semester. It is difficult to understand why any have chosen not to become full members as there are so many advantages to full membership: Full members have a voice in shaping our negotiations. Members enable HCAFA to speak strongly on their behalf. Members support our profession. Members take advantage of \$1,000,000 workplace liability insurance. Members can get special rates for insurance, travel, shopping and enhanced legal services. Members are supported by IEA staff and attorneys on work-related issues.

3. Welcoming New Members and Formerly-Grandfathered Members.

All adjuncts that are in their 4th consecutive semester of teaching at least three-credit hours each semester are eligible to join HCAFA. In addition, our current contract states, "Beginning with the Fall 2015 semester, all HCAFA unit eligible adjunct employees regardless of date of hire, shall be required to maintain membership in the HCAFA or to pay Fair Share." We encourage everyone to become a full member for the reasons given above in the paragraph about Fair Share Fee Payers.

4. Working with IEA and NEA and Other Unions to Support Our Pensions and Unions.

Educational as well as other unions in Illinois are being attacked by the governor and his supporters. Educators' pensions are in jeopardy. IEA and NEA in coalition with other unions are working diligently to make sure that the threats against SURS (State Retirement System) do not become realities. IEA is working to keep collective bargaining as a basic right for all educational workers in Illinois.

5. Resolving Members' Grievances.

The purpose of the grievance system is to assure that the college follows our contract and treats employees in a fair manner. It would be nice to think that employees are always treated justly. For the most part, they are at Harper. However, there have been numerous instances in which HCAFA has had to come to the aid of HCAFA members to ensure their job assignment, to rectify professional development mistakes, to correct salary disputes, to prevent non-paid required hours of work, and to save adjuncts' jobs. Regardless of the issue, our grievance chair and committee are available to members in order to make sure that everything is as it is supposed to be.

6. Preparing to Negotiate Our Next Contract.

Our current contract expires in fall 2016. We want our next contract to meet the needs of our members. This fall we will send a survey to all full members asking them about their concerns. We expect negotiations to begin shortly after that, and we will incorporate these concerns into our negotiation strategy. We welcome additional members to our negotiating team.

7. Sending HCAFA Members to Training Programs and Representative Assemblies.

HCAFA believes that our union functions best when members are well-trained and fully informed. As a result, HCAFA and its parent organizations IEA and NEA sponsor and send HCAFA members to grievance training programs, higher ed meetings, emerging leaders conferences, leadership academies, finance workshops, political action forums, professional development opportunities, and representative assemblies from our region, IEA and NEA.

8. Setting up Events to Further Member Participation.

The HCAFA Executive Committee meets on a monthly basis. Our meeting dates are posted on our website as well as below in this newsletter. We encourage all members to become active and come to meetings. Add your voice. In addition to monthly meetings that are open to everyone, we have informational meetings, coffees, parties, and programs that you're encouraged to attend.

Dwain Thomas, AN ADJUNCT YOU SHOULD KNOW



Dwain Thomas, currently the Executive Committee representative for our library staff, has been active in HCAFA since its formation in the early 1990's.

His IEA-NEA background extends to his tenure as an English teacher and librarian at Lake Park High School in Roselle, from which he retired in 2000. Admittedly not a strong union supporter during the unit's formation there in the mid 1980's, he came to "see the light" as the district entrenched against its teachers' rights and working conditions. That same mindset encouraged his involvement with HCAFA, continuing to today in our relationship with the College. He's especially proud of the level of professionalism shown by our membership as we provide the majority of instruction and support to our students. The services HCAFA affords our members are a point of continuing delight.

Both of Dwain's children attended Harper, becoming full-time Harper students during the second semester of their senior year at Fremd High School. Tara, now a Kimberly-Clark representative on the Wal-Mart account in northwest Arkansas, and Tyler, a pilot for Berkshire-Hathaway based in Dallas, thought that their Harper classes were every bit as challenging as they later found at their universities.

Dwain, who lives in the River North neighborhood of downtown Chicago, is completing his thirtieth year as a reference librarian at the College. He particularly enjoys working with adults who have been away from formal education for a while, but who are returning to school and feel the special challenge of new technology. The library will be undergoing a major remodeling and expansion after this school year which is certain to add to the already wide services to and resources for our students.

Outside of school, Dwain takes every opportunity to travel; Eastern Europe and Buenos Aires are favorite destinations. He and his partner Marty visited Germany and Austria last spring, despite encountering rain ten of the fourteen days in their trip. He also works as a concierge at the Hyatt Regency Chicago and as a volunteer docent for the Chicago Greeter service.

While he obviously has a unique take on what "retirement" meant after leaving Lake Park, his years at Harper and his involvement with HCAFA have been important elements in his personal and professional life.

WHAT ARE MY WEINGARTEN RIGHTS?

If you are ever in a situation that you believe could lead to any kind of disciplinary action, you have the right to have a union representative with you. In a situation like that, to protect yourself, say, "If this discussion could in any way lead to my being disciplined or terminated, or affect my personal working conditions, I respectfully request that my union representative be present at the meeting. Without representation, I choose not to answer any questions." Under no circumstances should you lose your cool or walk out of the meeting.
