HCAFA CARES ABOUT ADJUNCTS NATIONWIDE!

HCAFA contacted members about National Adjunct Walkout Day (February 25) and urged adjuncts not to walk off the job. Our current contract is still in effect; therefore, walking off the job would not be legal. Although HCAFA supports the concept of publicizing the plight of adjuncts across the nation, we did not want anyone to be subject to discipline by the Harper administration.

It would be nice to think that the public and Harper recognized the inequities that adjuncts face and would strive to eliminate them. One adjunct commented that he would welcome the day when along with adjuncts, members of the administration the community, and students would hold a National Adjunct Walkout Day to protest the plight of adjuncts.

HCAFA CARES ABOUT YOUR CONCERNS REGARDING SHARED GOVERNANCE!

Shared Governance at Harper can only be valuable if there is meaningful representation of all employee groups. Although adjuncts are the largest employee group at Harper, adjuncts have been included in a limited capacity in Shared Governance. The role adjuncts play has become even more limited due to adjuncts' resigning from committees. Some adjuncts have expressed concern that their time working on Shared Governance committees is not valued by the College. Some have said that decisions about meeting times have resulted in inconvenient meeting times or times when they were not available. Others have said that they had to make special trips to Harper for the meetings even though they were not compensated for their time or mileage. HCAFA would like to have adjuncts play a stronger role in Shared Governance. We would like to see meetings planned around adjuncts' schedules with compensation for attending meetings and more value placed on their input.

HCAFA CARES ABOUT YOUR OPINION REGARDING THE EVALUATION SYSTEM!

Michael Bates (Associate Director of Café) and Jack Henderson (Assistant Director of CAFÉ have been enthusiastic and dedicated supporters of adjuncts. Recently they have taken on the evaluation system with the goal of figuring out how to improve it and make it more meaningful to adjuncts, the College, and the students we serve. The new pilot evaluation program provides three choices of evaluation methods: the traditional method, the reverse-peer evaluation method, and the goal-based method. At HCAFA's January Executive Committee Meeting, the Executive Committee agreed to pilot the new evaluation system for one more semester. If you have been evaluated using the new system, HCAFA would benefit from hearing your comments.

HCAFA CARES ABOUT PROTECTING YOUR RIGHTS

Special Circumstance Leave

Familiarize yourself with your contract.

"When all allotted personal days are used for circumstances beyond an adjunct employee's control, he/she can seek approval from his/her Dean for an additional day to use for a religious holiday, personal illness, or bereavement of a close relative."

The wording regarding Special Circumstance Leave in the 2012–2016 agreement with the college has been interpreted differently by HCAFA and the Harper administration. HCAFA understands the intent of the provision to be broader than the administration does. The College is interpreting the provision in its narrowest sense. HCAFA thinks that the Dean has the possibility of granting an extra day for significant reasons not itemized in the agreement. However, at this point, HCAFA has no choice but to accept the College's interpretation until a new contract is negotiated.

Professional Development

We'd like to remind you again of some of the professional development benefits you have—some available to all adjuncts at Harper and some only available to members.

Available to All Adjuncts:

- The Take-Home Software Program
- Any programs or classes sponsored by CAFE

Professional Development Money for Members Only (Article 9.14 of Adjunct Contract)

- <u>Librarians and Counselors</u> are now eligible for the same professional development money that adjunct teaching faculty are.
- Professional development activities eligible for pre-approval include, but are not limited to: <u>books</u>, <u>including electronic downloads</u>; <u>professional travel</u>; <u>tuition and fees for workshops</u>, <u>seminars</u>, <u>and college credit courses</u>; <u>expenses related to conferences</u>; <u>professional journals</u>; <u>and memberships in professional organizations</u> (which may include online access to journals).
- More money is available to each adjunct in our new contract. Each adjunct is <u>eligible to receive \$400</u>; in addition, if the adjunct's expenses exceed \$400, the adjunct may petition the Dean for additional money from the fund.
- Professional Development money <u>can be used for activities during the summer</u>. This will enable adjuncts to take classes or seminars during the summer when they have more free time.
- The pre-approval process is more thoughtful of particular circumstances than it was before. There is recognition that occasionally time is of the essence and an <u>adjunct may seek verbal approval</u> from a Dean because he/she may have to pay for the activity immediately and not be able to wait for final written approval of the activity.
- You can access the professional development form by going to www.harperadjuncts.org and clicking on the "Document" tab at the top. Then go to "Form on the Harper Portal" under the heading "Professional Development." You will be asked to log on to the Harper website. You will find the form under the heading "Most Requested Forms."

WHAT ARE MY WEINGARTEN RIGHTS?

If you are ever in a situation that you believe could lead to any kind of disciplinary action, you have the right to have a union representative with you. In a situation like that, to protect yourself, say, "If this discussion could in any way lead to my being disciplined or terminated, or affect my personal working conditions, I respectfully request that my union representative be present at the meeting. Without representation, I choose not to answer any questions." Under no circumstances should you lose your cool or walk out of the meeting.

FROM THE PRESIDENT

Dear HCAFA Colleagues,

I hope that your spring semester is going well.

Spring has not been a good time for unions. I am sure that you are aware that unions have been under attack in Illinois and across the nation. It is important to understand that the action Governor Rauner took recently does not impact IEA members; it only affects employees of the State of Illinois, not employees of school districts. However, the IEA, our parent organization, anticipates that the governor will eventually target IEA, IFT (The Illinois Federation of Teachers), and all public employee unions. If this does happen, as it has in Wisconsin and elsewhere, our IEA President, Cinda Klickna, believes that we will need to fight back. HCAFA and IEA may need to contact you immediately; therefore, it is important that IEA and HCAFA have your contact information.

Please give IEA your home email address. Your school email could be blocked, so we need to have your home email on file. In case of an emergency, we need your cell phone number so you can be alerted immediately via text when the attack comes. Either go to the IEA website at www.ieanea.org and go to the IEA member login or call IEA Connect toll free at 1-844-IEA-1800 to speak with an IEA staff person. IEA Connect calls are taken from 7:00 to 7:00, Monday through Friday. In addition, please email your contact information to HCAFA's membership chair, Gary Wilson, at www.hcafamembership@gmail.com.
