

WHAT ARE MY WEINGARTEN RIGHTS?

If you are ever in a situation that you believe could lead to any kind of disciplinary action, you have the right to have a union representative with you.

In a situation like that, to protect yourself, say, "If this discussion could in any way lead to my being disciplined or terminated, or affect my personal working conditions, I respectfully request that my union representative he the present at meeting. Without representation, choose not to answer any questions." Under no circumstances should you lose your cool or walk out of the meeting.

THE POLITICAL SCENE

The political scene continues to be a tumultuous one on every level. The US is sparring (only verbally so far) with both our historical allies as well as hostile countries with their own agendas. Frustration continues to build over the seeming inability of Congress to make movement on any significant proposals with the President stirring the pot. In Illinois, our financial abyss grows deeper as the gubernatorial race is already a mud—and dollar—sling fest. Let's see: which gazillionaire we want to take leadership, especially with assistance to our schools.

However, the U.S. Supreme Court may hold the future of organized labor as it agreed to hear the appeal of the *Janus v. AFSCME* over the issue of the legality of the "fair share" doctrine which requires members of bargaining units to contribute to the cost of negotiating and servicing their contract. The Supremes refused to hear 99.4% of the cases which appealed to them this year, but it agreed to review the forty-year-old policy it originally upheld. A similar case was before the court two years ago, but a 4-4 tie on the Supreme Court upheld the decision of the next lower court. Unfortunately, in the interval, President Trump appointed a ninth Court member whose background strongly indicates he will be pivotal in overturning the decision to, in effect, outlaw "fair share." A decision in *Janus* isn't expected until late winter at the earliest. We'll keep you informed.

Meanwhile, HCAFA continues to dialog with Harper's administration on numbers of issues and to provide assistance with employment issues which might lead to job protection through the grievance process. We're currently meeting with the administration to protect and enhance our members' rights as the adjunct employment Level 2 concept is developed.

Full membership is only a few dollars more than the "fair share" membership and strengthens us as a unit as well as expands the professional opportunities for each member. DOES THIS SOUND FAMILIAR?

Excerpted from an interview with Senator Dick Durban (D-ILL) in NEA's Education Votes (www.EdVotes.org) regarding S1927 introduced on October 5 and co-sponsored by Sen. Al Franken (D-MN): After its second reading, the bill has been referred to the Senate Committee on Health, Education, Labor, and Pensions.

About 25 percent of grad students owe at least \$100,000 in student debt, and unfortunately if they become adjunct faculty members—like two-thirds of all faculty—they can expect to earn about \$25,000 a year. Something that would help is to make adjunct faculty eligible for federal Public Service Loan Forgiveness, which is exactly the aim of your 2017 bill, "The Adjunct Faculty Loan Fairness Act." Can you tell us more about who you have in mind with this bill?



Adjunct and contingent faculty members play an important role in college classrooms across the country. They have advanced degrees. They teach classes and spend many hours outside the classroom preparing for class. They hold office hours, grade papers and give feedback to students. They provide

advice and write letters of recommendation. Students rely on them. They have student debt like full-time colleagues, yet because of a quirk in the Public Service Loan Forgiveness Program, don't qualify for assistance. My bill would recognize the critical contributions of adjunct faculty to America's higher education system by fixing this. Consider someone like Alyson, an adjunct professor from Chicago, who graduated with \$65,000 in student loan debt and, after 10 years of on-time payments, has more than \$56,000 left. Like most adjuncts, Alyson strings together multiple teaching assignments along with part-time work to afford her monthly living expenses and minimum student loan payments. She comes from a family of educators and considers teaching her dream job. I think the Public Service Loan Forgiveness Program should acknowledge her commitment and sacrifices.
