## Adjunct Colleagues,

We are sending you this brief e-newsletter with hopes that you and your families are all well and staying safe in these unusual times. By now, we hope that you are feeling comfortable with teaching online. We hope that the transition has happened smoothly and that you are on track for the end of the semester. If you are having any issues with teaching online, we strongly suggest that you contact the Academy. If you are having any technology issues, contact IT, or if you have a need for technology equipment, contact your dean.

HCAFA has been in close contact with the Provost and the President. We have also been in contact with Human Resources. We want to keep you in the loop. If you are teaching online in the summer, you may continue to do so. However, if you are planning to continue teaching online in the fall semester, you must have taken one of the approved teaching online courses at Harper. If you have already taken one of the approved classes at Harper, consider yourself qualified for the fall semester! If not, please check out the sign-ups for the approved classes on the Academy website. Harper is offering courses in May and in the summer months. These classes are free but will require about 30 hours of time for about 2 weeks. At this time, we do not know if classes will return to face-to-face classes this fall.

Since we are using our own internet, computers, etc. in order to teach Harper classes from home, the College will pay each of us who teach or work online a small stipend in addition to our regular pay for each paycheck. Pay will be retroactive to March 17th. As of the date of this e-newsletter, we do not have the exact figure, but it should be in the range of about \$20-30 per paycheck in addition to your regular pay.

We will update you with any other information that you may need as soon as we receive it. #### **WORKING AFTER RETIREMENT**

Once an adjunct retires from teaching or working at Harper they are not able to return to teaching or working for the College. The amount they earn doesn't affect this policy. #### PARKING SPACES FOR FACULTY AND STAFF

After 18 months of negotiations with the College, the Unfair Labor Practice (ULP) that HCAFA had filed with the Illinois Department of Labor was settled. HCAFA won back many of the parking spaces for faculty and staff that had been taken away by the College. These spaces are not in the same locations as before, but there are many that are closer to the buildings, which is what we wanted. The College will restripe the negotiated spaces with red lines this summer.

# <u>Problem? HCAFA is here to help!</u> WHAT ARE MY WEINGARTEN RIGHTS?

If you are ever in a situation that you believe could lead to any kind of disciplinary action, you have the right to have a union representative with you.

In a situation like that, to protect yourself, say, "If this discussion could in any way lead to my being disciplined or terminated, or affect my personal working conditions, I respectfully request that my union representative be present at the meeting. Without representation, I choose not to answer any questions." <u>Under no circumstances should you lose your cool or walk out of the meeting.</u>
