## **RECENT ISSUES**

### **Contract negotiations**

Before the end of the semester, HCAFA will begin negotiating with the Harper College executive team on a new contract. The negotiating team will consist of Robert Allare, Steven Titus and Amy Kaminski. Robert will stay on during negotiations while also assisting Doug DePalma by bringing him into the fold at these meetings. Our number one goal is to hammer out an economically equitable, long-term contract that pays you more per semester.

### Employee town hall – Tuesday, April 25<sup>th</sup>

President Avis Proctor and her executive cabinet will be holding a town hall on this date. If you have questions for the college and wish to participate, here is the description provided by the college in HIP. "To support our commitment to transparency and open communication, Harper will hold an employee Town Hall at 2 p.m. Tuesday, April 25, in the Wojcik Amphitheater, Building W. The format for the Town Hall will largely be Q&A. The event will also be streamed over Webex."

#### **New Provost Search**

In March, Dr. Proctor announced that our provost, Dr. MaryAnn Janosik, would be leaving her position to retire. This will be effective as of June 30<sup>th</sup>. Currently, a search firm is working with the twelve-person Provost hiring committee to cast a broad net across the Chicago-Metro area and the nation for a diverse set of candidates. The candidates will be pared down to three finalists. These finalists will appear on campus in early May. Robert Allare, Steven Titus, Doug DePalma and Charmian Tashjian from HCAFA will be meeting with these candidates during their campus visits and discussing their visions for the Provost position at Harper College going forward.

# **Problem? HCAFA is here to help!**WHAT ARE MY WEINGARTEN RIGHTS?

If you are ever in a situation that you believe could lead to any kind of disciplinary action, you have the right to have a union representative with you.

In a situation like that, to protect yourself, say, "If this discussion could in any way lead to my being disciplined or terminated, or affect my personal working conditions, I respectfully request that my union representative be present at the meeting. Without representation, I choose not to answer any questions." <u>Under no circumstances</u> should you lose your cool or walk out of the meeting.
