# **Spring union sign-up drives**

In the Spring 2024 semester, the HCAFA will be sending out notices on how to sign-up for the union if you are not already a member. Without a union, there is no protection for your Weingarten Rights. Without a union, there would be no liaison like VP Jennifer Merritt and myself to work with HR, the Provost's office, and every single division to communicate alterations and improvements to the adjunct's quality of working conditions. Most of all, without a union, there would have been no one to negotiate a contract. We would be at the whims of what the college would offer us.

Consider that all these efforts that HCAFA has fought for and worked with the college on is the reason why we have a contract until 2027. We do not want to go back to the way life ways for adjuncts 20 years ago before the union formed. We certainly do not want to resort to what is happening currently at Columbia College Chicago where adjuncts have been on strike for over one month due to poor pay and working conditions!

With all of this in mind, this Spring when you see HCAFA members at outreach events or emails from us about joining the union, seriously consider doing signing up if you are not a member.

## **DEI training and certification**

Our 2023-27 contract stipulates that all adjuncts must participate in two hours of DEI training on an annual basis. In a confirmation with the head of Human Resources and our Provost, adjuncts have until June of 2024 to complete this training. If you have not completed this training, I would highly recommend you do so this December or early on in 2024. The college and the union does not want hound members in May to complete the training.

## Problem? HCAFA is here to help! WHAT ARE MY WEINGARTEN RIGHTS?

If you are ever in a situation that you believe could lead to any kind of disciplinary action, you have the right to have a union representative with you.

In a situation like that, to protect yourself, say, "If this discussion could in any way lead to my being disciplined or terminated, or affect my personal working conditions, I respectfully request that my union representative be present at the meeting. Without representation, I choose not to answer any questions." Under no circumstances should you lose your cool or walk out of the meeting.
